Jussi Karlgren, Silo AI, Stockholm



Jussi Karlgren is a principal AI scientist at Silo AI and a docent of language technology at Helsinki University. He will give a general introduction to AI. How far has the technique developed and how far can it take us (or how far can it lead us astray)? In trademark law, a feeling for language is essential, such as how words are perceived emotionally, what associations they give, how people may confuse or not confuse words. What are the limits to AI based tools relative to the human understanding of language?

Jeppe Hudtloff Viinberg is Co-Founder and Attorney-at-Law at RightHub, Denmark.
