## 5. PAYMENT, REFUNDS AND CANCELLATIONS

Payment methods accepted are credit card and PayPal.

- If you pay by credit card, we will send to your bank a debit petition; the amount will not be debited from your account until authorized by your bank. The debit term will depend on the rules applied to the payment.
- If you pay by PayPal the amount of the purchases will be charged to the PayPal account immediately. In case of rejection of the bank, the order will be automatically cancelled, and the client will be informed by email.
