Speakers



Lars Thyresson is an attorney at law and one of the founders of HanssonThyresson. He has previously worked for the Swedish Patent & Registration Office's Trademark Unit. Lars has many years' experience of intellectual property issues in Sweden and abroad, with a special focus on trademark, design, copyright, marketing, and contract law. Lars is a European Trademark and Design Attorney, an Authorised IP Attorney and a member of SPOF, FICPI and SFIR/AIPPI. He also chairs the Swedish national association of Fédération Internationale des Conseils en Propriété Industrielle (FICPI), the international federation for IP professionals, patent, trademark, and design protection attorneys.



Dott. Roberto Pistolesi has an extensive experience both in prosecution and opposition procedures before the EPO, where he has been involved in more than 50 cases before the Opposition Divisions or the Boards of Appeal. He also has a wide expertise in multi-national patent litigations, having been involved in several litigations both in Italy and abroad (mainly USA, UK, Germany and France). In particular, he has been involved in patent litigations concerning the following active principles: alendronic acid, atorvastatin, cefaclor, citalopram, docetaxel, enoxaparin, esomeprazole, phosphatidylserine, gabapentin, irbesartan + HCT, latanoprost, olanzapine, omega-3, omeprazole, montelukast, quetiapine, ramipril, repaglinide, rupatadine, salmeterol + fluticasone, and terbinafine. He frequently advises clients on patent strategies and provides infringement and validity opinions. Roberto has been a technical expert of the Court of Milan since 2002 and of the Court of Venice since 2015, where he assists Judges in patent infringement and/or validity cases. He was also adjunct Professor at the "Università degli Studi" of Milan from 2011 to 2015, where he taught chemical patent practice to the students of Chemical Science, Industrial Chemistry and Biotechnology. Roberto was elected President of FICPI in 2022 and was the Secretary General of FICPI since April 2015. He was the chairman of FICPI's study and work commission dealing with inventions in the pharma and biotech area from April 2012 to April 2015.



Mr Julian Crump, former President of FICPI International and current President of FICPI Communication Council graduated from Cambridge University in 1988 with an honours degree in Natural Sciences, covering physics and cell biology, but with a focus on chemistry. Julian qualified as a Chartered Patent Attorney in 1993 and a European Patent Attorney in 1995. He won the Gill Prize for the highest marks overall in the UK qualifying examination, and the Ballantyne Prize for top marks in the Infringement & Validity paper. Julian has been working as a patent attorney for more than 30 years and joined Abel + Imray in 2018. His practice is focused on pharmaceuticals and medicinal chemistry, new medical treatments, biotechnology and medical devices, especially drug formulations and drug delivery forms, new chemical entities, biomarkers, vaccines and diagnostics/prognostics, but he also has experience in other technologies, including adjustable focal power lenses, augmented reality devices, food technology, materials, packaging, product-handling equipment and aircraft seating systems. Julian acts for a diverse range of clients ranging from start-ups to multinational corporations.
